| Letter from the Board Chair

Fiscal Year 2023 in Review

Greetings, everyone. I hope you are enjoying the season's beauty.

Our 2023 fiscal year marked a significant milestone for the Jackson Hole Land Trust (JHLT). In February, we officially launched Park County Open Lands, a new regional program dedicated to the wild and working lands surrounding the greater Cody area. We've long identified this critical portion of Wyoming's Greater Yellowstone Ecosystem as a priority for conservation, and this year we welcomed a passionate local advisory council, a program director, and a conservation project manager to bring on-the-ground expertise to our work in the area. The phones have been ringing off the hook with interest, reflecting the community's appetite for protected agricultural lands and wildlife habitat that make Northwest Wyoming so special.

As I've stepped into my new role as chair of the board, I'm thrilled to guide the efforts of the organization, from Park County, down the Wind River, to our flagship work in Jackson Hole, to here at our Green River Valley Program where it was a banner year. In our 2023 fiscal year, we hired a new regional director and partnered with local folks to protect 3,893 acres. This includes the agricultural lands and riparian habitat at the P\T Livestock Johnson Ranch northwest of Marbleton and Big Piney. A second easement on Sundance Mesa in Sweetwater County conserves high-quality winter wildlife habitat in the Red Desert, essential for our big game herds that had a tough time of it in last year's deep snow. There continues to be considerable interest and momentum in this area. As a long-time Sublette County resident, this regional work is near and dear to my heart.

The following pages showcase a year of conservation successes as told by many of the people who helped us get there. They also represent the conservation legacy we are creating with partners across the Greater Yellowstone Ecosystem. Thanks to your continued support, the Jackson Hole Land Trust is proud to protect Northwest Wyoming landscapes for current and future generations.

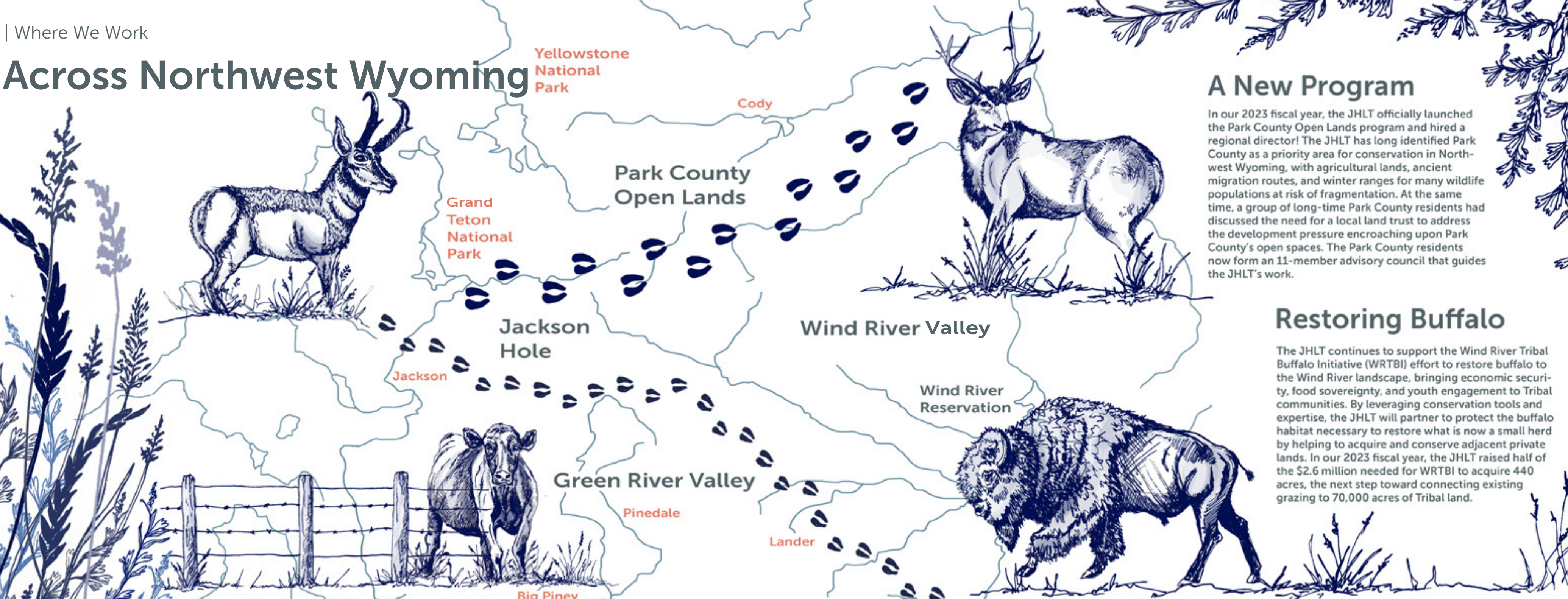

A New Program

In our 2023 fiscal year, the JHLT officially launched the Park County Open Lands program and hired a regional director! The JHLT has long identified Park County as a priority area for conservation in Northwest Wyoming, with agricultural lands, ancient migration routes, and winter ranges for many wildlife populations at risk of fragmentation. At the same time, a group of long-time Park County residents had discussed the need for a local land trust to address the development pressure encroaching upon Park County's open spaces. The Park County residents now form an 11-member advisory council that guides the JHLT's work.

Restoring Buffalo

The JHLT continues to support the Wind River Tribal Buffalo Initiative (WRTBI) effort to restore buffalo to the Wind River landscape, bringing economic security, food sovereignty, and youth engagement to Tribal communities. By leveraging conservation tools and expertise, the JHLT will partner to protect the buffalo habitat necessary to restore what is now a small herd by helping to acquire and conserve adjacent private lands. In our 2023 fiscal year, the JHLT raised half of the \$2.6 million needed for WRTBI to acquire 440 acres, the next step toward connecting existing grazing to 70,000 acres of Tribal land.

| Our Conservation Values

Working Agricultural Lands

Northwest Wyoming's farms and ranches are the backbone of this region. They are the foundations of our food system and provide essential wildlife connectivity. The Jackson Hole Land Trust is proud to partner with families across this corner of the state to protect working agricultural lands through conservation easements. These easements not only ensure a future land base for agricultural economies but also protect the way of life, generations of dedicated stewardship, and ranching heritage.

This past year, thanks to your support, the JHLT secured an 853-acre easement on Middle Piney Creek, partnered with Teton Conservation District on the production of the "Mountain Neighbor Handbook: A Local's Guide to Stewardship in the Tetons," and spoke at dozens of events to landowners interested in pursuing conservation easements.

Wildlife Habitat

Northwest Wyoming's national parks and forests support an incredible diversity of wildlife from grizzlies to moose and songbirds to raptors. But what about the places in between our network of public lands? Research increasingly shows the importance of private lands to wildlife, especially migrating ungulates.

The JHLT is proud to partner with you to continue taking on priority projects. In our 2023 fiscal year, the JHLT secured a 3,040-acre easement in the heart of the Red Desert, protecting vital habitat that is even more important in the harsh winters like last year. The JHLT partnered with the Johnson Ranch to protect 299 acres of moose calving habitat northwest of Marbleton and Big Piney (see previous page).
